Over 20% of Canadian private operators have already signed up for CBAA's new RMS

th the launch of CBAA's new Risk Management System (RMS) in November 2016, private operators have a new and powerful tool to assist in their regulatory compliance.

The RMS has been created in cooperation with our program partners, On-Board Data

Systems (OBDS) and Aerofoil Consulting, as a comprehensive approach to 604 compliance. Available to CBAA members only, we are able to offer it at no charge thanks to the generous sponsorship of Bombardier Business Aircraft and NAV CANADA.

The RMS features a clean interface and dashboard, using pulldown check lists and other simple-to-use features to ensure that information can be uploaded and downloaded quickly and confidentially. Security is assured with the use of the latest security protocols, with all data stored in Canada.

The online-RMS has been designed for smaller operators, which comprise the vast majority of Canadian private

operations; however, a template operations manual and SMS is available for larger operators. Sample operations manuals for both "no employees" and "with employees" operations which address both

PPC and TTPP competency certification programs are provided.

Other features of the program include a system to document compliance with SMS, QA and review of SMS requirements and access to the National Aggregate Databased, which now features the



CBAA members meet with the chair of the Liberal Aerospace Caucus

BAA has made substantial progress in its campaign to educate Parliamentarians on the value of business aviation, including holding several meetings with Leona Alleslev, Member of Parliament for Aurora-Oak Ridges-Richmond Hill. As well as chairing the Liberal Aerospace Caucus, Ms Alleslev is also the Parliamentary Secretary to the Minister of Public Services and Procurement.

A number of CBAA's directors and members met with Ms Alleslev in December to determine how we could work with her to build political support with members of the Liberal Aerospace Caucus and other influential elected officials.

Ms Alleslev, who is a former Canadian Air Force Officer and former Senior Manager for Aircraft Manufacturing at Bombardier Aerospace, first contacted the CBAA when she received a copy of our Economic Impact Study. With her background in aviation and aerospace, she brings an extensive understanding



and knowledge of our issues and challenges, including flight and duty time regulations, access to airports and other challenges.

This represents a significant step in the evolution of CBAA's ability to influence government decision-making at the most senior levels, which also included meetings with Saint-Léonard—Saint-Michel Liberal MP Nicola Di Iorio who was instrumental in helping us meet with senior political staff in the minister of Revenue's office to advance our advocacy on taxation issues.

Update on Flight & Duty Time regulations

n December 2016, CBAA joined with eight other aviation associations requesting a meeting with Minister Garneau to stop the imposition of 705 regulations on 704 operations prior to their release in Canada Gazette I in spring 2017.

While our 604 member are not affected, those who operate 704 charter flights would be, and on their behalf, the CBAA has determined that four (of ten) proposed regulations are unacceptable: Flight Duty Period; Extension of FDP Due to In-Flight Rest; Unaugmented Long Range Flights and Standby.

Special 604 authorization delegation requested

he CBAA has made an official request to TC for a Special Authorization delegation from TC to non-government experts, which would include the delegation to administer the PORD submission. Our goal is to offload these tasks from TC to another party to achieve the same speedy turnaround time as we currently have with CBAA's Type Rating delegates. •

measure, targets & goals) and results, review SMS results and contribute de-identified SMS data to the National Aggregate Database (NAD). The NAD aggregates this risk and safety data and provides users with the sector risk profile, common hazards, safety trends, safety lessons



learned, best practices and mitigations and this de-identified information is available to all RMS registrants.

The RMS is one element of the CBAA Partners in Safety program, which also includes a 604 SMS and other features.
